**Urgent Alert: Beware of Hoax Email Allegedly from OMESTI Berhad**

It has come to our attention that some Members of the Bar received an email this morning (Tuesday, 10 Sept 2019) allegedly from an official at OMESTI Berhad.

The email states the email address of the sender as [nor.hafiz@omesti.com](mailto:nor.hafiz@omesti.com), and the subject as "REVIEW".

OMESTI Berhad has informed us that this email account has been compromised, and that recipients of the email should immediately delete the email. Members are advised **not** to click on any link contained in the body of the email, or open any attachment that may have been included with the email.

The content of the hoax email is reproduced below for your reference.

OMESTI Berhad has assured us that it has investigated the matter, and has taken action to ensure that this incident does not recur.
